In particular please review the rules for runway use and conflict resolution. These rules are particularly important to prevent inadvertent conflict between fixed wing and soft wing aircraft flying at WAP.

New to this issue is the first of our club Safety and Training Officer's monthly safety columns, "Skull Sez". 2007 saw a tragic, fatal crash out west involving our most experienced airman, and several very near missies at WAP involving a PPG, a PPC, and a fixed wing ultralight. Please help Dave by contributing to this vital monthly safety message.

Skull Sez ...

FROM THE CLUB 1 SAFETY HANGAR

Season's greetings and I hope you and your family had a festive, joyous, and safe holiday season. Thanks to Tom and Len for updating and publishing the WAP Rules and Regulations. With the Airpark getting more popular all of the time [and well deserved] and with the increase in aircraft of all kinds, I plan on spending a few minutes each monthly Club meeting discussing some "Skull Sez" points on safety around the field. These are discussions, which means I want your input and remarks about the topics discussed.

At January's meeting I plan on touching on the Airpark Rules and Regulations and airing any questions or concerns Club members might have about the rules. Then I want to start in on a multimeeting topic of getting to know the different types of flying machines that we have and encounter around the field. We will take about 15 minutes at each meeting and discuss different aircraft and their characteristics. I will be asking for volunteers that fly that particular kind of aircraft [let me know before hand who is willing to speak] to cover Trikes, PPCs, true Ultralights, Experimentals, Light Sport Aircraft, and finally General Aircraft. I want to cover the basics of each aircraft, like your takeoff speed, take-off roll, climb rate, cruise speed, normal cruising altitude, pattern speed, approach and touch down speeds, stall speed, critical times in the pattern, etc. I would also like each pilot to touch on critical things or procedures if there is a mishap with your aircraft [i.e. ballistic chute; fuel cutoff valves, etc.] My goal is to raise the awareness of the pilots in the Club, so for example, if I'm in my PPG approaching the field and I see an ultralight turning crosswind in the pattern, I'll know he is focused on his turn to final, his speed is just above stall, and he will probably land. Or if an ultralight is overflying the field and sees a PPG pilot out of his seat and turning into the wind, the ultralight pilot would know that the PPG pilot is on "final" and will soon be turning off his motor and will be committed

to landing. If we learn more about what the other guy is doing in his aircraft, it should be safer above and on the field.

February we'll have a PPC and Trike pilot speak. Step up and volunteer! [Steve are you still interested?] March will be true ultralight and an experimental aircraft pilot. In April I will ask for LSA and GA pilots to speak.

So, by the time we get into the heart of the flying season, we should be familiar with the other aircraft based out of WAP. On down days or if the winds pick up and we can't get airborne, I'd like to see more show and tell of each other's aircraft besides the hangar talk and the "there I was..." stories.

Each month I will try to touch on any mishaps across the aircraft types that I can find information on, to again raise our awareness, not to point the finger on lay blame on the pilot. If you have any other suggestions for safety topics, let me know.

If it has been a long time since you've flown last, remember to take the time to walk through the entire flight in your mind before even stepping near your aircraft. Go through some "What ifs" with yourself and maybe even break out your checklists for the first few flights. See you at the Airpark!

Warrenton Airpark

Rules and Regulations (Revised 1/02/2008)

- 1. General Facilities:
 - a. Status: Private Airport Operated by Warrenton Airpark, LLC, Tom Richards, Owner
 - b. Field Identifier 7VG0
 - c. Field Elevation: 442 ft MSL
 - d. Runways 04/22 2300 ft long, 15/33 2000 ft long, and abandoned runway 15/33.
 - e. Radio frequency for Local Coordination: 122.9 MHZ.
- 2. General Rules: Aircraft using Warrenton Airpark vary from Hot Air Balloons to General Aviation to include Powered Parachutes, Powered Paragliders, Ultralight Aircraft, Experimental, and factory-built aircraft. It is possible to share this space safely only if the rules of common courtesy and the FAR's are followed as appropriate. Operators of each type of aircraft should be aware of all other aircraft operating at the same time. For example, any time fixed wing aircraft are operating in the vicinity of the Airpark, Powered Parachutes and Powered Paragliders should avoid overflying the 04/22 and 15/33 runways at or below pattern altitude. All pilots must fly in accordance with all FAR's with special emphasis on yielding the runway to aircraft that are flying the pattern — presumably with intent to land.
- 3. Use a Left Hand Pattern for Landing and Takeoff for Runways 04 and 22. Use a Left Hand Pattern for Landing on Runway 33. Abandoned Runway 15/33 can be used by Powered Parachutes and Powered Paragliders but crossing the intersection of Runways 04/22 should be avoided unless a safety observer is at the intersection coordinating traffic. Other aircraft should avoid using abandoned Runways 15/33 except for emergencies or strong crosswinds on 04/22.

- 4. Do not fly over any houses within 1 mile of the Airpark below 1000 ft AGL (1442 ft MSL).
- 5. Minimum pattern altitude is 500 ft AGL or 942 ft MSL.
- 6. Departures on Runway 04 must turn before crossing over Beach Road and houses beyond.
- 7. Left Traffic landing on Runway 04 <u>must avoid</u> flying over the "Green Roofed House" ½ mile Southwest of the airport.
- 8. Go-Arounds when using Runway 33 for landing will depart straight out or turn left only.
- 9. Tenants and guests please avoid driving on the airfield at any time. Parking is available around the circle driveway by the Clubhouse.
- 10. Tie downs are available on the tree line on the entrance side of the runway 04/22.
- 11. Please help us keep the airfield litter free. Trash cans are provided.
- 12. Access to and use of the Clubhouse The Clubhouse now serves as the full-time residence of Tom Richards and his daughter, Janet. Hangar and Tie-down Tenants, USUA Flying Club 1 members, and other visitors to the Airpark are welcome to continue using the clubhouse pretty much as before i.e. access to the restroom at any time, refreshments* are usually available in the refrigerator on the front porch (honor system) and continued use for USUA Flying Club 1 meetings, Fly-Ins, parties and such.
 - * Refreshments = sodas, cold water and beer (no beer before flying please - per the FAR)
- 13. During Fly Ins:
 - a. The Club 1 Safety Staff may authorize specific exceptions to these rules.
 - b. All pilots flying during a fly in must register and be briefed by the safety staff.

- c. Ground Traffic:
- 1. Vehicles on the field will be limited to travel from the entrance gate to designated parking areas.
- 2. Unloading and loading may be done only in areas authorized by the Safety Officer.
- 3. Go carts and ATV's are not permitted on the field, except for the USUA Flying Club 1 utility cart when operated by authorized drivers.
- 4. Pedestrians must avoid aircraft operation areas and especially the runways during flight operations.
- 14. No Training Operations permitted, except Hanger and Tie-Down tenants may train for proficiency.
- 15. All Hangar and Tie-Down tenants must have liability insurance for the operation of their aircraft.
- 16. This is a Private Airport. All aircraft that are not Hangar and Tie-Down tenants are required to obtain permission from the Airport Owner before landing. If USUA Flying Club 1 obtains permission to hold a Club 1 activity on the field, all attending that activity automatically have permission from the Airport Owner to land unless specifically denied permission by the Airport Owner in writing. All Club 1 Members in good standing automatically have permission to land unless specifically denied permission by the Airport Owner in writing. All who land are required to comply with these rules and regulations.
- 17. If you are unable to adhere to any of these procedures, please land at some other field and contact the Airpark for transportation. The management and tenants welcome your comments or suggestions for more enjoyable, safer and quieter flight operations.
